Under our BlueCycle Reclamation Program, no carpet fiber ever finds its way to landfill.

INSTALLATION	INSTALLATION PROCEDURE	EnPress Adhesive Application Non Mohawk Group adhesives will not be compatible and will void product warranties. If Self Lock carpet tiles have been purchased, the adhesive has been pre-applied to the backing. Carpet tiles can be installed directly to the floor with no additional adhesive. If the substrate is dusty or porous, use The Mohawk Group's Prime-Coat to prime the surface.

		For PVC and Thermoplastic carpet tiles, apply the adhesive with a heavy-duty frame paint roller with 3/8" nap roller. For Ecoflex tiles, apply the adhesive with a 1/16 x 1/16 square notched trowel as directed by the adhesive label. The adhesive must be applied in a FULL SPREAD – NOT grid.
