INSTALLATION	INSTALLATION PROCEDURE	Wall must be completely smooth before applying then apply primer of your choice. Apply clear adhesive (that is not thinned with chemical solvent) to back of fabric. Allow the adhesive to become tacky before applying. After applying do not clean with water. Let any excess adhesive dry and then take off with dry brush. DO NOT WET THE FABRIC.
