<b>MAINTENANCE</b>	<b>AFTER INSTALLATION</b>	W (water based cleaners): To prevent overall soiling, frequent vacuuming or light brushing to remove dust and grime is recommended. Spot clean using the foam only from a water-based cleaning agent such as a mild detergent or non-solvent upholstery shampoo. Apply foam with a soft rag or brush in a circular motion. Vacuum when dry. Always pretest a small area before proceeding.
